

News

- Retail & E-Commerce: Total amount of U.S. Sales (4Q2019) was: 1.38 Trillion. 4Q2019 E-Commerce and Retail were up 2.6%. An increase of 6.1 Billion (+ 0.7%) from 3Q2019. E-commerce sales alone in 19Q4 increased by 16.7% from 4Q2018. An estimated 22.2 Billion dollars increase from previous year. Retail sales alone only increased 0.4% from 3Q2019. (CA DOF)
- Consumer Spending: Increased moderately in 4Q2019; supported by a 4.1% rise in personal income in the 4Q2019 compared to 4Q2018. 4Q2019 consumer spending, increased by 1.4% compared to last year; 3Q2019, increased by 1.4%; 2Q2019, increased by 1.4%. (BEA)
- CA Labor Market: Unemployment rate dropped to 3.9% in 4Q2019. The U.S. Unemployment Rate remained the same at 3.5% in 4Q2019. California's Labor Force Participation Rate declined by 0.1% in 4Q2019. (CA DOF)
