**PROJECT No. 5504 Central Harbor Park and Boat Launch Facilities**

**NOTICE TO BIDDERS:**

The following clarifications, amendments, additions and/or deletions as set forth herein shall apply to the above project contract documents and shall be made a part thereof and shall be subject to all the requirements thereof as though originally specified and/or shown. Submitters shall assure themselves that all addendum changes have been incorporated into their proposal.

**A. ADDITIONS/DELETIONS**

1. **Replace** item 1 of the “NOTICE INVITING BIDS”. The Bid Opening has been **POSTPONED to Tuesday July 30, 2024 at 2:00 p.m.**

**Bid Submission.** City of Pittsburg (“City”) will accept sealed bids for its Central Harbor Park and Boat Launch Facilities Project (“Project”), by or before **TUESDAY JULY 30, 2024, at 2:00PM**, at Pittsburg City Hall, located at 65 Civic Avenue, First Floor, Pittsburg, California, at which time the bids will be publicly opened and read aloud.

**B. CLARIFICATIONS**

Please be advised of the following clarifications to the contract documents:

1. Bid Items 3 and 86 indicated that there are 20 tree removals. However, the drawings only indicate 19 tree removals. Please clarify how many trees are to be removed for this project. In addition, could you indicate which trees are part of Add Alt 1 and which are part of the Base Bid?

*There are 20 trees to be removed and will be part of the base bid.*

2. **Additive and Deductive Alternates.** As required by Public Contract Code § 20103.8, this bid solicitation includes additive or deductive items, the method below will be used to determine the lowest bid. City retains the right to add to or deduct from the Contract any of the additive or deductive alternates included in the Bid Proposal.

X   (A) The lowest bid will be the lowest bid price on the base contract without consideration of the prices on the additive or deductive items.

**BIDDERS MUST SIGN AND ATTACH** one (1) copy of this addendum document to the proposal as acknowledgment of receipt of these instructions and that said addendum was properly evaluated in the proposal.

**ANY PROPOSAL NOT IN COMPLIANCE WITH THIS ADDENDUM MAY BE REJECTED.**
