Supplemental Law Enforcement Services Account (SLESA)

The Citizens Option for Public Safety (COPS) program was originally adopted in 1996 with funding from the state general fund. One component of the funding was for front-line law enforcement. State COPS funding is allocated by the State Controller to law enforcement agencies in the Supplemental Law Enforcement Services Account

As part of the 2011 realignment of various public safety programs from the state to local government, the Legislature approved the Local Law Enforcement Services Act and shifted all remaining motor vehicle license fee (MVLF) revenue to pay for various local law enforcement grant programs including the COPS/SLESA programs (SB89). Front line law enforcement funds are allocated to cities, counties and five police protection districts on a population basis.

Supplemental Law Enforcement Services Account (SLESA)

Government Code section 30062(a) states that moneys allocated from a Supplemental Law Enforcement Services Account (SLESA) to a recipient entity shall be expended exclusively to provide front line law enforcement services. These moneys shall supplement existing services, and shall not be used to supplant any existing funding for law enforcement services. There is no fiscal impact to the General Fund.

The Chief of Police is requesting future annual SLESA allocations be dedicated to front-line police services equipment, technological upgrades, non-reimbursable training courses, training resources and conferences.
